Describe the manufacturing processes (elaborate to provide as much detail as possible)	Fabrication, assembly, and installation of digital CCTV field equipment, including color video camera units; camera lenses, filters, control circuits, and accessories; camera housing; medium-duty pan and tilt units; video and camera control and power cable connectors and assemblies; video, data, and power surge suppression; and built-in ID generator. Materials must be new, corrosion-resistant, and in strict accordance with TxDOT Special Specification 6018

External screws, nuts, and locking washers must be stainless steel. Parts must be made of corrosion-resistant material, including plastic, stainless steel, anodized aluminum, or brass. Materials must be protected from fungus growth and deterioration due to sustained moisture. Dissimilar metals must be separated by an inert dielectric material

Equipment must support Cohu, Pelco D, or Pelco P protocols, or approved equal. Encoded video must be interoperable with hardware and software decoders from at least two other manufacturers in use by TxDOT. A minimum 3-year warranty is required.
